

#### **Government and Commerce**

Peru has maintained a consular presence in Georgia since 1995, when the Honorary Consulate opened, to be followed by the 2006 opening of a Consulate General. The office has jurisdiction over six southeastern U.S. states. Mr. Giancarlo Leon Collazos has served as Consul General since March 2023.

The State of Georgia has had representation in Peru since 2018. Manuel Puma serves as the state's representative in the market.

The Peruvian-American Business Chamber of Georgia, a division of the Georgia Hispanic Chamber of Commerce, promotes business, tourism and investment between Peru and the United States.

The Georgia Hispanic Chamber of Commerce was founded in Atlanta in 1984 and promotes the domestic and international economic development of Hispanic businesses and business people. The organization seeks to bring the issues and concerns of the growing number of Hispanic entrepreneurs to the forefront of Georgia's economic agenda.

The fourth annual Americas Competitiveness Forum (ACF) was held in Atlanta in November 2010, marking the second time Atlanta hosted the ACF. The purpose of the forum is to provide an opportunity for governments, business community and representatives from academia and non-governmental organizations to discuss actions that can be taken to improve competitiveness and economic prosperity in the Americas.

During his time in Congress, former Governor Nathan Deal voted in favor of an agreement between the United States and Peru to promote free trade in 2008.

The Georgia Department of Economic Development organized a trade mission to Peru in March 2023.

Decatur, Georgia has a sister city agreement with Trujillo, Peru.

#### **Academics**

In the Fall semester of 2024, 171 Peruvian students will be enrolled in USG schools.

The University System of Georgia (USG) offers 21 study abroad programs to Peru in programs such as language, psychology, nursing and international business.

Emory University also provides programs for students to study abroad in Peru.

### Arts and Culture

Founded in Atlanta in 2008 by Peruvian native John Zorilla, the organization Apu Inka records and promotes Latin American folk music and traditions and performs concerts around the world.

In December, 2017, the Michael C. Carlos Museum hosted the exhibit, Threads, which focused on the history of textiles in Central and South America, including Peruvian textiles.

Eva Ayllón, one of Peru's most enduring stars, performed in 2018 at the Rialto Center for the Arts in Atlanta.

### International Trade

The United States-Peru Trade Promotion Agreement (PTPA), a comprehensive bilateral free trade agreement, took effect on February 1, 2009.

EXPORTS: In 2023, Georgia exports to Peru totaled \$185.7 million. Peru is the 43rd largest export market for Georgia.

Top exports from Georgia to Peru include civilian aircraft, poultry, kraft paper and paperboard, cotton, and pumps for liquids.

Georgia leads the nation in the export of the following goods to Peru: poultry, kraft paper and paperboard, insecticides, wood in the rough, and machine tools for working metal.

IMPORTS: In 2023, Georgia imports from Peru totaled \$242.6 million. Peru ranks 44th among Georgia's importer nations.

Top imports from Peru to Georgia include grapes, onions and shallots, refined copper, coffee, and men's shirts.

# **Transportation**

Hartsfield-Jackson Atlanta International Airport offers daily non-stop flights from Atlanta to Lima, Peru. In 2024, the airport expects 680 flights carry 174,000 passengers. The airport celebrated LATAM Airlines inaugural Atlanta-Lima, Peru flight in late 2023.

The Georgia Ports Authority (GPA) in Brunswick has an established relationship with the ports of Peru and offers shipping services to Callao.
